ATHLETE ACCEPTANCE, RELEASE AND RENUNCIATION

In order for my application to be accepted, I officially declare on behalf of myself and / or my heirs, executors or attorneys that I waive any right and claim for damages now or in the future against Natural Bodybuilding & Fitness Italy (NBFi), of the members, sponsors, the organizer, their representatives, employees, successors and agents, concerning or attributable to the **INBA/ PNBA NATURAL BODYBUILDING WORLD CHAMPIONSHIP event carried out in June 2022**, including the rights and claims for damages for related physical and / or moral damage to the urine test or to any publication or other dissemination of the results of the aforementioned test and for any damage suffered by me on the way to and from the place where the event took place, following the granting of permission to participate.

Following the acceptance of my application, I am also aware of the following:

1. the competition is open only to competitors who in the last **10 years** (duration of the drug-free period) have not taken anabolic steroids, growth hormones, diuretics or other prescription drugs to improve physical performance and who, in case of victory, I will be subjected to a **urinalysis, or blood, or other test that INBA GLOBAL / PNBA through the NBFi deems appropriate to add**, to determine if I am not taking or taking any medications. Following the acceptance of my application, I am also aware of the following:
2. I am aware, and I accept, that I may also be subjected to a surprise urine test, **or other tests that the INBA GLOBAL / PNBA through the NBFi deems appropriate to add**, during the period of contest, a test performed by a representative anti-doping agency, certified, GQS by NBFi / INBA Global / PNBA.
3. The results definitive of the urinalysis, following the operations of the laboratory operator, will be binding and unassailable.
4. The testing laboratory is authorized to disclose the test results to the NBFi and to any protesters (and their employees or representatives).

I confirm that I have viewed the WADA LIST of PROHIBITED SUBSTANCES and METHODS (updated as of January 1, 2022) what is reported at the following links:
